4. REVISION AND ADOPTION OF THE AGENDA

5. READING, CORRECTION AND APPROVAL OF PREVIOUS BOARD MINUTES

PRESIDENT'S REPORT

TREASURER'S REPORT

Jack Wheat reported that income was in excess of expenses for October and there were all "yes's" on the financials for the month.

7. UNFINISHED BUSINESS

Electrical/Generator Project for Main Office – Jeff Feasel reported that the engineer had approved the equipment for the office project. The equipment was ordered by Kelly Energy and would be available in 4-6 weeks. There will be a final meet between AWC, Kelly Energy, and the Trico representative before breaking ground. Cost to complete the project is roughly estimated at \$35,000 which is the cost of the generator plus 10-15% for incidentals i.e. concrete pad, conduit, and supplies. Micha Koeppel suggested the warranty be strongly considered before deciding on the two generator estimates.

Noel Reservoir Pumps – Jeff Feasel also reported that of the three pumps at Noel, Pump 1 had a motor and impeller replaced by AWC staff last year improving flows from 200 gpm to 245 +/- gpm. Pump 2 will be approximately \$5,000-6,000 to upgrade. This upgrade will take it from a 10hp to 15hp with the hope of a 300 +/- gpm. This cost includes super-efficient motor and electrical upgrades. AWC will have to put in some labor and minor costs to retro-fit. Estimates were from Grand Canyon Pump and Pump's Inc. Pump 3 is brand new and as per the two pump company representatives, it should remain the same. They both agreed the original design was not very efficient. It would require a taller tank or pump set in vault to improve the efficiency. Suggestions by the vendors were to run the pump with higher tank levels.

MOTION: A motion was made by Jack Wheat to move forward on the generator project.

MOTION: A motion was made by Jack Wheat to move forward with the pumps at Noel Reservoir.

CNH Capital Backhoe Lease – Jeff Feasel reported that our Case 580SN backhoe lease expires on 2/28/15. Our options are to buy out the lease at \$37,387.20, extend the lease another year, or turn the backhoe into the dealer and lease a new backhoe. Jeff spoke with Titan Machinery and they are offering close out prices on their entire stock with 3 year full machine warranties. Next year's equipment comes with new emissions technology which will raise prices \$10-12,000. Staff will look into what a new lease would be and check on extending the lease for one additional year.

Jeff Mechanical & E-file – Regular maintenance agreements are due for our air conditioning vendor and our data storage software. Jett Mechanical is offering a special of \$120 for each unit which includes a spring and fall maintenance and 10% off any work that is necessary. E-file is offering a three year maintenance agreement for \$1,077 which is a savings of \$270. This should finish up our need of E-file as we make the transition of saving all of our customer's data on to the new server.
