Community Development Block Grant – We finally heard from Pima County regarding our survey on February 24th and they approved our survey. Now we are waiting for the contract to come and once Doug signs it, we can get it back to Pima County and purchase our meters and MXU's.

Hoover Power Update – Cathy spoke with Trico and they had sent over a Bill Credit sample. Based on the sample it states we would have a \$412.22 savings per month. This is based on their \$0.024290 current electric cost. As costs go up, our savings should go up as well. They are sending over a simplified Bill Credit sample this next week and using costs from the APA's ten year estimate and will send a draft of the Bill Crediting Contract as well.

Service Area Roads – Cathy and Jeff sent Pima County a list with photographs of the areas with bad roads. Pima County said they were not public roads and therefor will not repair them. We will be looking for grant's that would help with repairing these roads.

CAP Transfer - ADWR received all of the additional information they had requested from TOM and AWC. It was accepted and a letter was sent out for Public Notification regarding the transfer. I forwarded the email on March 3rd to the board. The public has until April 18th to submit their written comments.

DNP's - There were 38 disconnections due to non-payment for February 2016.

8. OPERATIONS MANAGER'S REPORT

Picture Rocks School – The new lines and tie-in are complete. Operations used four trailer loads of dirt from the school project to fill in a sinkhole/washout over the 6" main on Lydia Rd.

Hydrant Maintenance/Flushing – The guys have been working on hydrant maintenance; PRV's and DVA flushing, easement and meter box cleaning.

A new service was installed in Section 35 and 1 service replacement/relocation in Section 20. There was a leak repair done in section 9 which turned out to be an actual theft of water service.
