### 8. OPERATIONS MANAGER'S REPORT

- We had two new service installs in Section 16 and 35.
- Well #11: Bestway Electric repaired the top bearings of the motor and it is back in service.
- Had a leak just off of Picture Rocks from a garbage truck running over it. We repaired and I met with the homeowners for service relocation as this has been an ongoing issue.
- Pima County came out to do the site inspections. We passed that and have received certification.
- Generator battery at Noel has had problems for several months. We had Gentech come out once again and they replaced and upgraded the trickle charger.
- Cleaning section 34 for meter replacements.
- Tank divers were here to do their inspections. Based on their evaluation, all tanks looked good with the exception of Van Ark. Will look for quotes in the next month or two and anticipate a rehab/coating in October of this year.
- Chlorine Generator and Pothole machine Our Cl2 generator stopped working for a short time, it is repaired and functioning now. Have contacted PSI for a proposal for a 20 & 40lb Cl2 generator as the life span is 10 years and we have had it 14 years. We are looking to purchase a second pothole machine, that we can repair leaks in separate areas at the same time.

**MOTION:** A motion was made by Dayv Marlow to reallocate 2019/2020 budget capital funds to the purchase of a new chlorinating system and pothole machine.

9.1 COVID-19 Discussion – The office has been running smoothly. Customers have been really cooperative and paying their bills or making payment arrangements. The ACC has been focusing on A & B utilities, AWC is a C utility, but we are paying attention in case their moratorium affects us. We finally found hand sanitizer and we hope to be receiving another order soon.

### 10. NEW BUSINESS -

**10.1 Possible Federal Funding** — Staff will continue to look at possible funding available to us. The ACC moved to allowing corporations to apply for CARES Act /SBA loans/grant funding and relayed that at the April 15 open meeting. Unfortunately, those funds will probably be exhausted by the end of the day now that we have the approval.
