

Water Harvesting Rebate Program

Avra Water Co-op, Inc will offer rebates of up to \$3,000 for qualifying water harvesting system components purchased and installed either through a qualifying vendor or home improvement store.

Eligibility and Requirements:

- Must be a single-family residential Avra Water Co-op member in good standing who meets the requirements stated below:

Requirements:

- Application must be completed by the AWC member with active water service at the installation address.
- Applicant must provide a valid, legible sales receipt(s) dated April 3, 2024 or later. Receipt(s) must include the rebate item(s) purchased to include container(s), pipes, gutters, or other components for the water harvesting system, and include the purchase price.
- Applicant must provide a description of the water harvesting system, along with a picture of the installed system showing the home so verification can be made.
- Applicant will be required to attend & complete our Rainwater Harvesting Workshop in order to qualify for this rebate. Workshops will be held free in person at our office, please check the website at AvraWater.com for workshop dates.
- Households that have already reached the rebate limit will not be eligible for any additional water harvesting grant rebates.

Please Note:

- Applications will be processed in the order they are received.
- All required documentation/pictures must be submitted to AWC before your application can be approved.
- If approved, a rebate check will be issued to you within 7 – 10 business days and mailed via U.S. Postal Service to the address on your application.
- We may require a site visit by one of our AWC technicians prior to approving your application.

• **The Water Conservation Grant Rebate will continue until all grant funds have been expended or by 5/31/2026 (whichever comes first). Any pressurized systems, including submersible pumps in tanks, will need to install a backflow RPA (Reduce Pressure Assembly) at the meter.**
